The following is a copy of a paper now (1886) in the possession of Polly Heffner:

"BERKS COUNTY, SS Whereas Henry Heffner of Jacob Baldy's Company in Col. Philip Gehr's Battalion hath made Complaint to us, the Subscribers, Commissioners of said County that he could not attend at the Muster and Field day. In 1777 and 1778 he was a Prisoner of War and not exchanged, and we finding his complaint just, do therefore agreeable to an Act of General Assembly, passed the twenty-seventh Day of March 1780, acquit and exonerate the said Henry Heffner from the fine which he might have incurred from not attending said Muster and Field days. Given under our hands, the fourthe day of October, in the Year of Our Lord, One thousand, seven hundred and ninety.

It granted by the said Commonwealth unto the said Anthony Heffner. A certain tract of land called ROCK FOREST, situate in Rockland Township, Berks County. Beginning at a White Oak, thence by the land of Henry Mertz south eighty degrees, west eighty perches to a post, north ten degrees, west thirty-six degrees, west thirty-six perches to a stone. Know ye that for and in consideration of the sum of three hundred pounds in Gold and Silver money unto me in hand well and truly paid by John Heffner of the Township of Rockland in the County of Berks aforesaid yeoman the receipt whereof I do hereby acknowledge and the said John Heffner his heirs executors or administrators thereof and every part thereof forever acquit have granted, bargained sold released and confirmed and by these presents do grant bargain sell alien release and confirm unto the said John Heffner his heirs and assigns, All those three following described tracts of land situate separate from each other in the Township of Pinegrove aforesaid bounded as follows to wit. Following is John's Last Will and Testament:

I, John Heffner considering the uncertainty of this mortal life and being of sound mind and memory, do make and publish this my last will and testament in manner and form following, that is to say, first I give and bequeath unto my wife Leah Heffner, such of my household furniture and kitchen utensils as she may choose to keep for her own use, and one cow. Item, I give and bequeath unto my said wife the sum of one hundred dollars yearly and every year during her natural life the first payment thereof to be made one year after my decease by my hereinafter mentioned executors or the survivors of them. Item, it is my will that all my Real Estate in the Borough of Pottsville, the House and lot in the Borough of Orwigsburg, the undivided half of my house and lot of ground in Friedensburg, shall be lease out by my Executors so long as they think proper, then to be sold at public vendue to the higher bidder, Item it is my will that my plantation situate in Wayne township now in the possession of Jacob Emerich containing ninety acres more or less adjoining lands of Joseph Fertig, Abraham Fertig and other land of the Testator shall be leased out by my Executors during the life of my Daughter Catharina, the wife of Philip Boyer, and the proceeds thereof to be paid to her yearly and every year and after her decease the same to be sold and the proceeds thereof to be equally divided among all her children, share and share alike. Item, it is my Will that the lease made with Andrew Fox (?) and the two Raynolds to remain as stipulated in the lease aforesaid. Item, it is my Will that my son Jacob Heffner shall have the sum of five hundred dollars, which shall be paid to him by my Executors out of my Estate one year after my decease. Item, it is my will that the undivided half of my Grist Mill and twenty five (?) Wayne Township owned in partnership with Michael Wommer shall be leased out during the natural life of my son Jacob aforesaid and the proceeds thereof to be paid to him yearly and every year and after his decease to be sold by my Executors and the proceeds arising therefrom to be equally divided among all his children share and share alike. Item, it is my will that Daniel Albright, the son of my Daughter Elizabeth deceased, shall have the sum of six hundred dollars to be paid to him by my Executors as soon as he arrives at the age of twenty one years. Item, it is my Will that my Son John Heffner shall hold and occupy my Plantation now in his possession for the term of five years after my decease, on the same condition and under the same contract that he is now holding the same and on the expiration of the aforesaid term, the same shall be appraised by a jury of twelve men to be selected by my Executors or the survivor of them and he may take the same at the appraisement, of the aforesaid twelve men, but in case he does not proper to accept the same at the appraisement aforesaid then it shall be sold at public vendue to the highest bidder. Item, it is my Will and I do order and direct that all my moveable Estate goods and chattels of what kind or nature soever, which I have not herein before bequeathed shall be sold by public vendue, the proceeds thereof to be equally divided among five of my children to my son John Heffner, my Daughter Judith the wife of George Moyer, my son William Heffner my son George Heffner and my daughter Hetty the wife of John Freeman. Item, it is my will and I do hereby bequeath unto my son George, my black mare, saddle and bridle and one bed and one chest. Share and share alike and the

bequeaths heretofore mentioned to my daughter Catharina the wife of Philip Boyer, and my Son Jacob Heffner and Daniel Albright, the son of my Daughter Elizabeth deceased, shall be considered in full of all their dues out of my estate and they shall in no way be instilled to recover any part thereof whatsoever - except what is aforesaid, and lastly, I nominate, constitute and appoint my son John Heffner and my son-in-law George Moyer to be the Executors of this, my last Will and Testament hereby revoking all other Wills, Legacies and bequeaths by me heretofore made and declaring this and no other to be my Last Will and Testament.

In Witness whereof I have hereunto let my hand and seal the nineteenth day of February AD one thousand eight hundred and thirty nine.

The Miner's Journal and Pottsville General Advertiser dated March 2, 1839 printed a one line obituary for John. It reads: "DIED "On Saturday evening last, in this Borough, John Heffner, Senr. in the 64th year of his life".

This obituary is nestled between a poem called 'And Sand Filled up the Palaces of Old.' and an article called the 'State of the Thermometer' which recorded three daily temperature readings for the week of February 22 through the 28th in the year 1839.
